

RESOLUTION 2009-16

A RESOLUTION APPROVING RATE INCREASES FOR SOLID WASTE COLLECTION SERVICES PROVIDED BY R. SANITARY SERVICE PURSUANT TO GARIBALDI MUNICIPAL CODE CHAPTER 8.05.

WHEREAS, Garibaldi Municipal Code Chapter 8.05 (enacted by ordinance No. 165 on 8/22/89, and as amended), granting a franchise to R. Sanitary Service for the collection of solid waste in the City of Garibaldi, requires approval by the City Council of all rate increases following a public hearing by the City Council; and

WHEREAS, R. Sanitary Service has proposed an increase in solid waste collection rates, which rates are proposed to be effective 1 August 2009; and

WHEREAS, the Council, having held the said public hearing, finds the proposed increase justified pursuant to Garibaldi Municipal Code Chapter 8.05; NOW, THEREFORE


THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:

Section 1. The schedule of solid waste collection rates, as submitted by R. Sanitary Service, is hereby approved. The said schedule is attached hereto as EXHIBIT A.

Section 2. The request by R. Sanitary Service, that the said rates be in effect 1 August 2009, is hereby approved.

Section 3. This Resolution shall be effective upon its passage by the Council and approval by the Mayor.
