

RESOLUTION NO. 2010-23

A RESOLUTION ESTABLISHING FEES FOR LAND USE AND BUILDING ACTION, AND ADMINISTRATIVE SERVICES

WHEREAS, the City of Garibaldi has determined that rates regarding City services such as land use permits, public record requests, document reproduction, and incidental financial costs should be adjusted by resolution; and

WHEREAS, the last fee change by resolution was in 2008 (Res. 2008-09); and

WHEREAS, ORS 192.227(1) provides that the governing body shall establish fees charged for processing permits at an amount no more than the actual or average cost of providing that service; and

WHEREAS, a methodology of calculating the average number of land use permits in a year, dividing that number by the average number of staff hours spent reviewing a land use permit, and scaling the average cost of City staff review by the structure value associated with individual land use applications as determined using the 2006 International Building Code valuation data, and adding a base fee that represents the minimum staff-review time required for any land use permit, produces a equitable and balanced fee for certain land use permits; and

WHEREAS, the City has determined the following established fees should be adjusted to compensate for current costs of providing these services; now, therefore

THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:

Section 1. The following fees shall be assessed at the time of application, effective September 1, 2010, and that this resolution supercedes all previous rate-setting resolutions.
