A RESOLUTION OF THE CITY COUNCIL SUPPORTING THE NORTH COAST SALMON & STEELHEAD ENHANCEMENT FUND, INC., AND ITS 2015 NORTH COAST SALMON RENDEZVOUS FISHING TOURNAMENT/FUNDRAISER BY WAIVER OF BUSINESS LICENSE REQUIREMENT

WHEREAS, the North Coast Salmon & Steelhead Enhancement fund (NCSSEF), Inc. (an Oregon Non Profit Corporation) holds an annual all volunteer fundraising event called the North Coast Salmon Rendezvous for the purpose of funding and/or leveraging critical fisheries projects along the North Oregon Coast; and,

WHEREAS, the NCSSEF has chosen to hold its 2015 North Coast Salmon Rendezvous event in Garibaldi, thereby contributing to our local economy and introducing and re-introducing their numerous participants and volunteers from outside our region to the charms of Garibaldi; and,

WHEREAS the Garibaldi City Council wishes has expressed its support for the NCSSEF by endorsing its nomination for the Tillamook County Futures Council 2015 Vision Award in Economy and Natural Resource Categories; and,

WHEREAS the Garibaldi City Council recognizes the positive economic impact that this event and organization have on Garibaldi and its neighboring communities over the course of the event by attracting professional fishing guides from across Oregon and Washington to Garibaldi to participate in the event,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:

Section 1. Waiver of Business License Fees for the 2015 North Coast Salmon Rendezvous.

The City of Garibaldi waives the requirement to apply and pay for a business license for all professional fishing guides participating in the 2015 North Coast Salmon Rendezvous for the dates of October 28, 29 and 30, 2015. This waiver only extends to guides that are not already licensed by the city, and that only operate out of Garibaldi during this event.

Section 2. Administration.

The Garibaldi City Council authorizes the City Manager to administer the provisions of this resolution. This waiver extends only to those professional guides who are recognized by the NCSSEF and the City of Garibaldi as participants in the 2015 North Coast Salmon Rendezvous.

Section 3. Effective date.

This resolution is effective as of the date of adoption.
