

RESOLUTION NO. 2007-17

**A RESOLUTION ESTABLISHING FEES, DEPOSITS AND POLICIES REGARDING THE CREATION AND ADMINISTRATION OF REIMBURSEMENT DISTRICTS.**

**WHEREAS**, Ord. No. 300 Allowing for the Creation and Administration of Reimbursement District (adopted 20 August 2007) provides in Section 3(D) that the council shall establish certain fees and charges by resolution; and

**WHEREAS**, the City Council annually establishes fees by resolution for the reimbursement of staff and contract employee time (last adopted 19 March 2007 through Res. No. 2007-03); NOW THEREFORE


**THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:**

**Section 1. Processing Fee for a Reimbursement District.** Actual costs will be charged for establishing the reimbursement district. The City Administrator will require a deposit estimating the actual costs and any of the deposit remaining when the process is completed will be returned to the payee. The Administrator may adjust the cost estimates based upon a preview of the application. If the process costs more than the deposit, the applicant shall be charged for the remaining costs.

**Section 2. Cost Estimating.** Resolution No. 2007-03 or subsequent resolutions will be used for determining staff rates. In addition, estimates for postage, recording fees and notice publishing will be based upon the most recent data available.

**Section 3. Deposit at time of adoption.** Upon adoption of this resolution, Exhibit A will represent the base charge for determining the deposit until staff rates, postage, recording fees and publishing costs are adjusted.
