

## RESOLUTION 2008-15

### A RESOLUTION EXTENDING WORKER'S COMPENSATION COVERAGE TO VOLUNTEERS OF THE CITY OF GARIBALDI.

**WHEREAS**, the City of Garibaldi is a participant in the City-County Insurance Services Worker's Compensation group; and

**WHEREAS**, the City adopted on 19 May 2003 Resolution 2003-09, electing to provide worker's compensation coverage to certain classes of volunteer workers pursuant to ORS 656.031, and setting the assumed wage for worker's compensation coverage for volunteer firefighters at \$2,000.00 per month in the 2006-07 budget year; and

**WHEREAS**, the City must also cover political volunteers pursuant to ORS 656.031 including the combined twenty members of the City Council, Planning Commission, Budget Committee, Urban Renewal Agency and Housing Rehab Loan Board; and

**WHEREAS**, said resolution provides for the updating of the above coverage annually by resolution of the City Council; NOW, THEREFORE

#### THE COMMON COUNCIL OF THE CITY OF GARIBALDI RESOLVES AS FOLLOWS:

**Section 1.** Pursuant to ORS 656.031, worker's compensation coverage will be provided to the classes of volunteer workers listed on the Volunteer Election Form that is hereby made part of this Resolution.

**Section 2.** An assumed wage of TWO-THOUSAND DOLLARS (\$2,000.00) per month will be used for the City's volunteer firefighters. The City has no volunteer police reserve officers because the City no longer operates its own Police Department.

**Section 3.** Political committees have an assumed wage of TWO-THOUSAND-FIVE-HUNDRED DOLLARS (\$2,500) per year per committee. The City has four committees that fit this definition: City Council, Planning Commission, Urban Renewal Agency and Housing Rehab Loan Board.


**Section 4.** Court-mandated community service workers/inmates on work release may be covered for worker's compensation benefits by the sentencing court. Coverage will be determined prior to work inception and stipulated to in writing between the City and the respective sentencing court. Court-mandated volunteers will keep track of their hours and have their assumed payroll reported in Class Code 7720V using Oregon minimum wage.

**Section 5.** A roster of active volunteers—public safety, non-public safety, and community service workers/inmates on work release--will be kept monthly for reporting purposes. It is acknowledged that City-County Insurance Service may request copies of these rosters during year-end audit.

**Section 6.** Unanticipated volunteer projects or exposure not addressed herein will be added onto the City of Garibaldi's coverage agreement by (1) endorsement, (2) with advance notice to City-County Insurance Services, and (3) allowing two (2) weeks for processing. It is hereby acknowledged that coverage of this type cannot be backdated.

**Section 7.** The provisions of this Resolution shall be effective 1 July 2008 for the fiscal year beginning 1 July 2008 and ending 30 June 2009. The worker's compensation coverage for volunteers that is the subject of this Resolution shall be updated annually by Resolution.
